Call to Order

Approval of the Minutes

Approval of the Financial Report

Ken reviewed the financials. There were no questions or comments. Mark made the motion, Virginia seconded, to approve the financial report. Motion carried.

Committee Reports

Bereavement:

Kathryn Jones wishes to step down as Chairman of Bereavement at the end of the church year. Several names were suggested as possible replacement. All standing committee chairpeople are appointed by the board chair.

Christian Education/Youth Ministry:

The end of the year Color Wars will be on the church south lawn the afternoon of May 9.

Mid-America summer church camps will resume with guidelines and limited numbers. Registration is online on a first-come-first-serve basis until camp is full. Information will be in upcoming bulletins and the newsletter.

Camps are taking place early June thru the 2nd week of August. Kris will remain on staff as needed to provide transportation to and from camps and to arrange payment and communication with the Region for camp.

Submitted a use request for tables/chairs in the parking lot for an all-day clothing give-away August 7. Virginia made the motion, Hope seconded, to approve this request. Motion carried.

Fellowship: No plans until fall.

Library:

Property:

Thanks to those who worked on the new mail/book drop. It is working well.

The boiler passed inspection.

There is still a leak around the south window. We have already paid \$400 to caulk around the stained glass. The wall is going to start rotting from the inside out if we don't do something. Septagon Construction recently inspected the project and has given a bid of \$1250 for repairs. Mark made the motion, Buddy seconded, to accept the bid. Motion carried.

The sump pump is causing problems again.

Worship:

Speaking coming through the lapel mic could not be heard in the parking lot Sunday.

Worship will continue as 8:00 and a dual service at 10:30.

There was discussion regarding the need to continue bulk mail at this time. 200 piece of mail are needed to quality. The \$245 renewal comes up May 1. It was decided to let it lapse.

Search Committee:

Old Business

Karla Hannaford, Wayne Buck, and Karolyn Caldwell each agreed to remain in their respective positions of Secretary, Treasurer, and Historian for the upcoming year. Mark made the motion, Kay seconded, to continue all positions through another year. Motion carried. Dan appointed Mark, Butch Ash, and Jill to diligently search for a Vice Chair.
